**BE IT ENACTED BY THE QUORUM COURT OF CRAIGHEAD COUNTY,
ARKANSAS; AN ORDINANCE TO BE ENTITLED:**

An Ordinance amending the 2017 Annual Operating Budget to add one full time position and salary to the Craighead County Assessor's Office in order to have the personnel available to fulfill necessary requirements at the Eastern District Courthouse.

SECTION 1. That the Craighead County Assessor is charged with fulfilling the requirements of the law as established for assessments and all other assessment related duties.

SECTION 2. That the Deputy Assessor Clerk will be responsible for duties associated with assessments and working with other Eastern District deputies as authorized by the County Assessor.

SECTION 3. That this additional appropriated salary and position will be created in the 2017 Annual Operating Budget to allow for accurate accounting of additional monies and expenditures as described below. Annual salary of \$40,500 will be prorated from June 1 through December 31, 2017.
