June 12, 2017 Quorum Court Meeting

13 Justices of the Peace Present

Judge Ed Hill called the meeting to order at 5:30pm.

Resolution 2017-7 was read concerning the support of the definition of navigable waters per Executive Order 13778 of President Donald John Trump. Justice Steve Cline motioned to accept the resolution, seconded by Justice Barbara Weinstock, all voted in favor of the resolution. – *Appendix 1*

Appropriation Ordinance 2017-6 was read concerning the establishing of an additional Collector's Office employee for the Jonesboro office. Justice Weinstock motioned to accept the ordinance, seconded by Justice David Tennison, all voted in favor of the ordinance. – *Appendix 2*

Appropriation Ordinance 2017-7 was read concerning the establishing of an additional Juvenile Deputy employee for the juvenile office. Justice Terry Couch motioned to accept the ordinance, seconded by Justice Dan Pasmore, all voted in favor of the ordinance. – *Appendix 3*

Appropriation Ordinance 2017-8 was read concerning the movement of a Collector's Office employee for the Lake City budget to the Jonesboro budget but maintaining the deputy in the Lake City office for accounting purposes. Justice Fred Bowers motioned to accept the ordinance, seconded by Justice Richard Rogers, all voted in favor of the ordinance. – *Appendix 4*

Justice Josh Longmire asked about the status of the salary survey stating he believed it was due to the court at this meeting. Assistant to the Judge Tony Thomas stated that this was a detailed process and that a firm had just been selected in the past few months to conduct such a survey and they would begin the process of collected necessary data from the appropriate officials, such as job titles and duties, in the coming weeks. Justice Longmire asked who was conducting the survey and was told by Assistant to the Judge Tony Thomas that the name of the firm had changed during the process of selection and he could not remember the new name but would get back with him and the court with this information. Judge Hill stated that he believed that this survey would be available for the court during one of the July meetings

Road Superintendent Eugene Neff passed out the monthly road report to the court. - Appendix 5

With no further business to be discussed Justice Couch motioned to adjourn the meeting into committees with a second from Justice Billie Sue Hoggard, all were in favor and the meeting stood adjourned at 5:50pm.

A Resolution of the Craighead County Quorum Court, Craighead County, Arkansas, USA Entitled: Comments to the EPA regarding Presidential Executive Order #13778 pertaining to correcting the definition of "navigable waters"

WHEREAS, President Donald John Trump has issued on February 28, 2017, an "Executive Order on Restoring the Rule of Law, Federalism and Economic Growth by Reviewing the 'Waters of the United States' Rule"; and

WHEREAS, Section 2 of that Executive Order calls for the review of the 2015 "Clean Water Rule: Definition of Waters of the United States" (as ordered on June 29, 2015 by the Obama administration), and that 2015 rule, because of its far-reaching federal intrusion into historic state and local properties, has been met with much alarm and therefore remains in challenging litigation to the present time; and

WHEREAS, President Trump's stated intent is to interpret the term "navigable waters" as defined in 33 U.S.C. 1362(7) (https://www.law.cornell.edu/uscode/text/33/1362) in a manner consistent with the opinion of Justice Antonin Scalia in Rapanos v. United States, 547 U.S. 715 (2006); and

WHEREAS, EPA and the Army Corps of Engineers are accepting substantive comments from state and local governments until June 19, 2017, stating the local county government position on the definition of "navigable waters" (EPA requests that comments be sent in written form to EPA staff at CWAwotus@epa.gov)

THEREFORE, BE IT RESOLVED BY THE CRAIGHEAD COUNTY QUORUM COURT THAT we support the Presidential Order pertaining to the making of the "Waters of the United States Rule" consistent with the interpretation of the term "navigable waters" in the opinion of Justice Antonin Scalia in Rapanos v. United States, 547 U.S. 715 (2006) (https://supreme.justia.com/cases/federal/us/547/715/opinion.html) https://www.law.cornell.edu/uscode/text/33/1362 thereby rescinding any portion of the 2015 Obama administration rule that is in conflict with the Justice Scalia opinion.

EPA, Corps request comments on 'Waters of the U.S.' rewrite

NACo and other national state and local government associations met with the Environmental Protection Agency (EPA) and the Army Corps of Engineers (Corps) regarding the agencies' upcoming "Waters of the U.S." (WOTUS) rulemaking. The formal consultation meeting resulted from President Trump's Feb. 28 executive order (RO) on Restoring the Rule of Law, Federalism, and Economic Growth by Reviewing the 'Waters of the United States' Rule. The EO directs EPA and the Corps to revisit and rewrite the 2015 WO-TUS rule.

The EPA and the Corps briefed state and local governments on their proposed two-step process to withdraw and rewrite the rule. Pirst, as part of the withdrawal effort, the agencies will move to reinstate pre-existing regulations and guidance that were in place prior to the 2015 WOTUS rule and currently used now due to the ongoing litigation with the 2015 rule.

Second, the agencies plan to develop a new WOTUS definition based on the late Supreme Court Justice Antonin Scalia's opinion in Rapanos u United States. Scalia's plurality opinion stated that federal jurisdiction should only include waters with a relatively permanent flow.

During the meeting, EPA and the Corps provided a presentation that included several options under consideration, "relatively including how permanent* waters and wetlands with a "continuous surface connection" should be defined. For example, should "relatively permanent" waters include "seasonal streams" that flow three months a year? Likewise, should wetlands with a "continuous surface connection" through non-jurisdictional features be regulated?

WOTUS is a term used in the Clean Water Act to define which waters (and their tributaries) fall under federal or state jurisdiction. In 2015, the Obama Administration finalized a new definition of WOTUS, which was immediately challenged in the colarts. Since the rule was originally proposed, NACo has expressed numerous concerns about the 2015 WOTUS impact on countymaintained ditches and other water infrastructure.

Background

The term "Waters of the U.S." is derived from a law that was passed in 1899, the Rivers and Harbors Act, that had to do with interstate commerce. Any ship involved in interstate commerce on a "navigable water," which, at the time, was a lake, river, ocean - was required to have a license for trading. The 1972 Clean Water Act first linked the term "navigable waters" with "waters of the U.S." to define the scope of the CWA programs such as the Section 402 National Pollution Discharge Elimination Program (NPDES), Section 404 Dredge and Fill permit program, Total Maximum Daily Loads (TM-DLs) and other water quality standards and state water quality certification programs.

In the past several decades, the term WOTUS has generally been fraught with controversy over where state jurisdiction ends and federal jurisdiction begins. In the realm of the CWA's Section 404 permit program, the courts have generally said that "navigable waters" goes beyond traditionally navigable-in-fact waters. However, the courts also acknowledge there is a limit to jurisdiction.

In 2001, in Solid Waste Agen-

cy of Northern Cook County (SWANCC) u United States Army Corps of Engineers, the Corps had used the "Migratory Bird Rule"— wherever a migratory bird could land — to claim federal jurisdiction over an isolated wetland. In SWANCC, the Supreme Court ruled that the Corps exceeded its authority and infringed on states' water and land rights.

In 2006, in Rapanos v. United States, the Corps was challenged over its intent to regulate isolated wetlands under the CWA Section 404 permit program. In a 4-1-4 split decision, the Court ruled that the Corps exceeded again exceeded its authority to regulate these isolated wetlands. Scalia's plurality opinion states that only waters with a relatively permanent flow should be federally regulated. Justice Anthony Kennedy's concurrent opinion stated that waters should be jurisdictional if the water has a "significant nexus" with a navigable water, either alone or with other similarly situated sites.

Since neither opinion was a majority opinion, it was unclear which opinion should be used in the field to assert jurisdiction, leading to further confusion over what waters are federally regulated under CWA.

In 2015, the EPA and the Corps finalized a new WOTUS rule based on Kennedy's opinion. Almost immediately, more than 30 states and private parties filed suits in various district and appeals courts. While the Shith Circuit Court of Appeals claimed the case and placed a nationwide stay on the rule until it could hear the case. there are ongoing questions on whether the Sixth Circuit Court of Appeals even has the authority to hear the case. This question is now ending before the U.S. Supreme Court which is expected to hear the this year and issue an opinion in 2018. The decision will strictly be on the judicial jurisdictional question and not on the basis of the 2015 rule.

SECTION 2. That this 7th Deputy Collector will be responsible for duties associated with tax collectors office and working with other Western District deputies as authorized by the County Collector.
