AN ORDINANCE AMENDING ORDINANCE NO. 2015-25 IN ORDER TO AUTHORIZE THE NET COLLECTIONS OF THE 2% SALES AND USE TAX LEVIED WITHIN THE CITY OF BROOKLAND, ARKANSAS BY ORDINANCE NO. 2015-25 TO BE USED TO PAY AND SECURE THE REPAYMENT OF BONDS APPROVED BY THE VOTERS AND ISSUED BY THE CITY FROM TIME TO TIME TO FINANCE AND REFINANCE CAPITAL IMPROVEMENTS; AND PRESCRIBING OTHER MATTERS RELATING THERETO.

REFUNDING BONDS

Bonds of the City of Brookland in the maximum aggregate principal amount of \$3,070,000 for the purpose of financing all or a portion of the costs of refunding the City's Sales and Use Tax Bonds, Series 2016 and, in order to pay the bonds, the pledge of a 2% local sales and use tax levied within the City by Ordinance No. 2015-25, adopted August 31, 2015, as it may be amended from time to time.

PARKS IMPROVEMENT BONDS

Bonds of the City of Brookland in the maximum aggregate principal amount of \$4,370,000 for the purpose of financing all or a portion of the costs of park and recreational facilities and improvements, including particularly, without limitation, ball fields, any land acquisition therefor, and any furnishings, equipment, utility adjustments and lighting, street, parking, landscaping, signage and drainage improvements related thereto or in support thereof and, in order to pay the bonds, the pledge of a 2% local sales and use tax levied within the City by Ordinance No. 2015-25, adopted August 31, 2015, as it may be amended from time to time.

MUNICIPAL BUILDING IMPROVEMENT BONDS

Bonds of the City of Brookland in the maximum aggregate principal amount of \$1,095,000 for the purpose of financing all or a portion of the costs of the acquisition, construction of a municipal building that contain city offices and a police station, any land acquisition therefor, and any furnishings, equipment, utility adjustments and lighting, street, parking, landscaping, signage and drainage improvements related thereto or in support thereof and, in order to pay the bonds, the pledge of a 2% local sales and use tax levied within the City by Ordinance No. 2015-25, adopted August 31, 2015, as it may be amended from time to time.

SEWER IMPROVEMENT BONDS

Bonds of the City of Brookland in the maximum aggregate principal amount of \$1,310,000 for the purpose of financing all or a portion of the costs of acquiring, constructing, and equipping extensions, betterments and improvements to the City's sewer facilities and, in order to pay the bonds, the pledge of a 2% local sales and use tax levied within the City by Ordinance No. 2015-25, adopted August 31, 2015, as it may be amended from time to time.
