
CACHE RIVER DRAINAGE DISTRICT OF

A contract with Glisson Enterprises accepting its low bid for clearing both ditches' banks in Section 3 of the plan, for the sum of \$381,225 was approved and signed. Work was almost entirely completed in 2018. The District secured a loan from Evolve Bank & Trust for \$100,000, payable in 5 annual installments, pledging all current revenues.
