June 11, 2012
Roads and Transportation Committee

Members of the Roads and Transportation Committee assembled at 7:18 pm after the meeting of the full court. Members present included: Terry Couch, Mike Cox, Mike Hawkins, and David Tennison. Others present included Eugene Neff—Road Superintendent, Judge Hill, and Tony Thomas.

Justice Cox called the meeting to order and the following business was discussed:

1. Eugene Neff delivered his monthly road report to the full court.
2. Eugene Neff addressed the following:
 - a. Questions about cuts in the road from CWL and plates in the road. A general inquiry was made about when cuts are repaired and general time frames for the plates to remain in the road.
 - b. CR 745 is being built up as a potential paving project.
 - c. Questions were asked about grave diggings that appear on the monthly report and what criteria are used by the department to provide this service. Generally this is a service provided for paupers or someone that has work with the county (including family at times).
3. Justice Hawkins inquired about the status of summer mowing. Neff indicated there had been some problems with the equipment but quick repairs were made and mowing was progressing well.
4. Additional graders are being prepared for sale as consideration is being given to purchasing additional new ones.
5. Justice Couch shared how Cross County was grading roads using a different piece of equipment other than graders and asked Neff to look into this
