

District Assessor: The Assessment of Benefits was completed and approved at the time the District was formed. No one now serves as Assessor.

Levies of Benefits (Taxes): Collected and forwarded to the District by the County Tax Collector or Treasurer; received by the District's Secretary/Treasurer, Mickey Seeman.

Delinquent Penalties: Assessed by County officials, according to penalties set out in State law.

Assessment Computations: Upon information and belief, flat per acre tax is the basis of the assessment. Per state law, this does not require an assessment. This assessment computation was handled by the Craighead County Tax Collector in the past, but currently is being handled by the Craighead County Tax Assessor.
